#### **OVERVIEW**

Central Line-Associated Bloodstream Infections (CLABSIs) and Catheter-Associated Urinary Tract Infections (CAUTIs) remain a significant contribution to patient harm and financial losses. The problem may call for a different approach.

Quality implementation science tells us that significant practice and process variation can lead to lower quality and higher cost. It makes sustainability almost impossible. The first step in this journey is dissection of both physician and nursing practices and processes followed by application of laser target strategies.

This session focuses on key practice areas where significant variation has been identified through a national frontline consultation experience. Innovative assessment techniques and evidence-based strategies are outlined to address both insertion and maintenance related to central lines and indwelling urinary catheters. The challenge to incorporating new evidence into practice lies in altering routinized behavior and current culture to support new care practices.
